Program Location

The Anko'tasik Coordinator will be affiliated with **First Nations Education Initiative Inc. (FNEII)**, acting as a second-level service provider for the North Shore Mi'kmaq Tribal Council (NSMTC). These positions are remote-friendly, with regular travel required to assigned First Nation communities. A valid driver's license and access to reliable transportation are essential.

Program Description

The **Anko'tasik initiative** is a culturally grounded, community-led wraparound model that supports the mental wellness of children and youth across the seven Mi'kmaq communities of NSMTC. This initiative strengthens interagency collaboration across health, education, and social services, centering the voices, strengths, and needs of **L'nu youth and families**.

Position Summary

We are seeking individuals with strong coordination and leadership skills who are passionate about supporting **L'nu youth and families** through culturally rooted, relationship-based service models. Whether your background is in health, education, social work, or clinical services, this position focuses on creating safe, collaborative systems of care.

It is a leadership role grounded in relationships, built on respect for Mi'kmaq values, culture, and language, and focused on improving outcomes for children and youth.

Key Responsibilities

Community Engagement & Partnership Development

This is a high-priority area of the Anko'tasik initiative. Candidates should demonstrate strong relational experience and a commitment to working collaboratively with L'nu families, communities, and service partners.

- Work collaboratively with families, communities, and service providers
- Strengthen partnerships across health, education, and social service networks
- Engage regularly with Executive Directors and local leadership

Collaboration with Clinical Service Providers

- Work alongside clinical service providers to support high-quality, culturally safe service delivery
- Collaborate with wraparound staff on complex cases in coordination with clinical teams
- Support effective communication and referrals between community, regional, and clinical partners (e.g., psychologists, OT, SLP, BCBA)
- Ensure services reflect Anko'tasik's community-informed clinical standards and shared ethical practices
- Respect and uphold privacy and data-sharing agreements developed with community input

Note: *Candidates are not expected to be subject matter experts in all areas listed below. We encourage applicants to share how their past experiences and activities relate to these responsibilities, even if from different sectors or roles.*

The responsibilities listed below reflect foundational priority areas that support the project and will continue to evolve as the Anko'tasik initiative develops.

- Support recruitment and onboarding of new team members

- Coordinate cross-sectoral care for youth and families at risk
 - Maintain effective communication across schools, government departments, and community agencies
 - Participate in quality improvement processes guided by community input and evaluation findings
